OVERVIEW

The Imperial County Film Commission is proud to host a series of virtual film festivals with the goal of encouraging filmmakers, their craft and to provide an audience for their work. The upcoming festival is open to all genres of storytelling.

FILM AND VIDEO ENTRY CRITERIA

All entries must be the sole creative and technical effort of the individual submitting the work. Entries will be no longer than 20 minutes.

FILM FESTIVAL ENTRY FEE

The film festivals will be free to filmmakers.

ENTRY DEADLINE:

All entries must be received no later than January 10, 2022. NO EXCEPTIONS.

VIRTUAL FESTIVAL SCREENING

Virtual screening will take place January 22-29 on Vimeo. A link to the festival will be emailed to you.

FESTIVAL RULES & INSTRUCTIONS

1. Entries received after the deadline will not be accepted.
2. Multiple entries are allowed however, each entry must be submitted separately.
3. Entries will be accepted that adhere to the Motion Picture Association of America Rating Board System, which includes General Audience (G), Parental Guide Suggested (PG), Parents Strongly Cautioned for anyone below the age of 13 (PG-13) and Restricted to anyone below the age of 17 (R).
4. Any film or video containing R-rated material, nudity, graphic violence, or in the exclusive opinion of the Imperial County Film Commission glamorizes drug use/ drug references alcohol or cigarette consumption, will not be accepted. Films that would be considered NC-17 will not be accepted.
5. In order to expedite online viewing, end credit viewing speeds may be increased.
6. Entry to the Festival does not guarantee acceptance for judging/screening.
7. Notifications will be sent to each applicant once entry is reviewed.
8. All films/videos and application must be submitted electronically through Dropbox, Google Drive, WeTransfer.com or Vimeo (with download link enabled) or emailed to imperialvalleyff@gmail.com.
